**GOLF COURSE POLICY: General Rules of Play**

**2100**

- 1. All Players must register with the Pro Shop staff at least fifteen (15) minutes prior to scheduled tee time
- 2. No more than four players in a group shall be permitted & Members are permitted to play in groups of five.
- 3. Each player must have a set of clubs. Each set of clubs must be in a separate bag.
- 4. Children who play and are knowledgeable of golf rules & etiquette may play the course with an adult or at the discretion of the Professional Staff
- 5. The Pro Shop reserves the right to refuse play if members or guests are intoxicated or under the influence of drugs.
- 6. No outside alcohol is permitted on the premises as per AGLC Regulations. Any players found in violation will be asked to leave the premises immediately.

**The procedure for cancelling tee times is as follows:**

- 1. Members are required to call and cancel if they are unable to make the tee time or if the number of players has changed at least **12 hours in advance** of the booked time. For cancellation of early morning times notice must be received the previous evening. Failure to provide proper cancellation notice will be dealt with as follows:
  - Members First offence: Letter from office explaining second offence procedure
  - Member’s Second offence: loss of booking privileges for one week, plus the cost of lost tee times, based on current prices. The cost of lost tee times is defined by the total number booked minus the number of players to play. For example, if a booking is made for four players on a weekend and three players show up, the Member who made the booking will pay the fourth green fee.
  - Non-Members/Green Fee Players: Loss of booking privileges for two weeks

**PRO SHOP POLICY: Members Charge Accounts**

**5100**

**Charging Privileges**

- 1. Members will have the ability to charge purchases from Food & Beverage and Pro Shop (tournaments, leagues, goods, etc). The member charging must have a signature and photo on file of all Members permitted to charge on a given account.

**Food & Beverage Requirements**

- a. **All active shareholders get 10% off all food and beverage purchases. All Purchases from the Beverage Cart must be charged to your account to get the 10% off.**
- b. All active Shareholder Members, or any Shareholders who would like to have charging privileges, must spend a minimum of \$300 by November 30<sup>th</sup> of the given year in the Stix Restaurant & Lounge. Purchases from the Beverage Cart must be charged to be applied to this \$300 requirement.
- c. For purchases to be applied towards the \$300 total, the Member must have their account selected when finalizing the purchase (paying).
- d. Statements for Food & Beverage purchases only, will be available through the Administration office.
- e. Family accounts will be setup. For example, shareholder and spouse: their charges will be added together for one total. Similar if there were Intermediate or juniors under a Shareholder, if permitted to charge, they would be added to the main shareholder account and the charges would be added together.
- f. **If by November 30<sup>th</sup> of the given year, the minimum has not been reached, the balance thereof will be charged to the Members Club Account.**
- g. **MONTHLY STATEMENTS ARE AVAILABLE ONLINE AND WILL NOT BE MAILED OUT UNLESS REQUESTED THROUGH THE ADMINISTRATION OFFICE.**

**GOLF COURSE POLICY: Dress Code**

**2200**

- 1. Shirts must be always worn. Shirts with offensive sayings or slogans are not permitted.
- 2. Men’s Attire: must have sleeves and cannot be torn or ripped and must be clean – tank tops and cut off sleeves are not permitted.
- 3. Ladies Attire: Tank tops and sleeveless shirts are acceptable. Ladies must have a 5-inch inseam or greater.
- 4. Nonmetal spikes or soft soled shoes are to be worn. Cleated footwear (football/soccer) or boots (cowboy boots) with heels are not permitted
- 5. Jeans, pants & shorts are permitted provided they are neat in appearance. Men’s shorts must have 7-inch inseam or greater. Pro Shop staff will strictly enforce and have the right to refuse golfing privileges to anyone who does not follow the set Dress Code

**Waiver:** I, \_\_\_\_\_ (“Renter”), agree that in consideration of being permitted to use Strathmore Golf Club (“Club”) golf cart (“Cart”) located at 80 Wheatland Trail, Strathmore, Alberta, do hereby release, waive, discharge and covenant not to sue Club, its members, officers, employees and agents from liability from any and all claims, including the negligence of Club, resulting in personal injury, accidents or illnesses, including death, and property loss arising from use of the Cart(s) used for the tournament or event name listed below. **Assumption of Risks:** Use and control of a golf cart, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, from one location to another, from one individual to another, but the risks of driving, riding, or using a golf cart range from minor injuries to major and catastrophic injuries including paralysis and death. I understand and agree that it is my responsibility to assess the hazards presented by my use of said Cart and further agree that I am the ultimate judge as to whether I can use the Cart without risk of harm to myself and others. **Indemnification and Hold Harmless:** I also agree to DEFEND, INDEMNIFY AND HOLD HARMLESS the Club, its members, officers, employees, and agents, from and against all claims, demands, actions, or causes of actions, for costs, attorney’s fees, expenses or damages to personal property, or personal injury, or death, which may result from any use of the Cart. **Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risk is intended to be as broad and inclusive as is permitted by the law of the Province of Alberta and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Users: I understand and agree that only adults sixteen (16) years of age or older that sign this agreement and hold a valid Driver’s License shall be allowed to operate the Cart.** Acknowledgment of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue the Club, its members, officers, employees, and agents. I also understand that this agreement binds my heirs, executors, personal representatives, attorneys-of-law, attorneys-in-fact, administrators, players, and guests of tournaments represented, and assigns, as well as myself. I acknowledge that I am signing the agreement freely and voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I hereby assert that my use of said Cart is voluntary and that I, and all players and guests of tournaments involved in, knowingly assume all such risks incident to using said Cart.
